### **NEIGHBORHOOD PARKS**

The tennis court paving and pickleball lines at Johnston Park is behind schedule due to weather and will be completed at the beginning of Spring 2019.

The tennis and basketball courts have been resurfaced in December. New concrete work, benches and color coding on the courts will be finished in the Spring.

The Perimeter Trail section from the Wetlands Trail to the intersection of Morton Road and Rostrun Drive is 95% complete. Phase 2 is still under design with the engineer.

The dek hockey court will be redone in the spring. The basketball court is looking good.

### **NEW BUSINESS**

Brick pillars will be installed at The Playground Pavilion at Boyce Mayview Park, as well as electrical outlets have been completed.

The Miracle Field will be adding a shed for more storage space.

Restrooms at the Boyce Mayview Pavilion are still being worked on and are expected to be finished in 2019.

**NEW BUSINESS (continued)**

The McLaughlin Run Activity Center (MAC) is about 99% complete. The landscaping will be finished in the spring. Open house dates January 28<sup>th</sup> 5pm – 7pm and January 30<sup>th</sup> 10am – 12pm.

The board members discussed the new software at the Community & Recreation Center (C&RC) and the new Assistant Community Programs Coordinator. Also discussed was the MLK Day program that had about 75 participants, including students from the University of Pittsburgh.

The Facility Implementation Team (FIT) Committee is made up of Commissioners, community members/C&RC users and staff members. This group is to help make recommendations on the original C&RC implementation.
