### **NEIGHBORHOOD PARKS**

Municipal tennis courts 1 and 2 have been repaved. Color coding will begin in approximately 30 days.

The tennis courts and paths have been paved at Brynwick and Johnston Parks. Landscaping has begun as well. The color coding will begin in approximately 30 days, then the pickleball lines will be added.

The golf course is up and running. The bridge from 2nd tee to the 2nd green has been removed. A new fiber glass bridge will be installed in the upcoming weeks.

The roof and scoreboard at Morton Complex was replaced.

The McLaughlin Run Activity Center (MAC) landscaping has been completed. The horseshoe pits will be removed.

The hockey court fence at Wiltshire Park has been replaced. The hockey court will be repaved and color coded in the upcoming weeks. Signs will be posted to give notice.

The Perimeter Trail section from the Wetlands Trail to the intersection of Morton Road and Rostron Drive is 95% complete. Phase 2 is in the design phase and grants have been submitted for the Phase 2B section.

The restrooms at the parks are slowly opening. We need warmer temperatures to turn on the water.

Construction began at The Boyce Mayview Pavilion for restrooms to be connected to the building. Work will continue through the 2019.

Grass and new trees have been planted to replace the mulch in front of The Community & Recreation Center at Boyce Mayview Park.

The board discussed the positive feedback regarding the baseball and softball fields. They look nicer this year than they have been last year. Some WPIAL playoff games will be held at the Boyce Mayview Fields.

Board members discussed the sidewalks on Morrow and how to reach out to reduce the speed limit on Mayview Road. Also the locker room shower temperature was discussed.
