- § 80.1. Storage or accumulation of unlicensed or junked vehicles prohibited.**

In order to promote the health, welfare and safety of the general public, and for the general welfare of the community, and in accordance with the police powers of the community, it is hereby declared unlawful to store, accumulate or keep openly on any residential, commercial or industrial property within the limits of the Township of Upper St. Clair or upon any private street, public street or driveway therefor any motor vehicle, whether an automobile or a truck or any trailer which is not licensed or which has been discarded or junked or which has any body parts removed or any vehicle in such a condition which would render the vehicle inoperable for highway use, or a vehicle which has an expired State inspection sticker, or for which the title of the vehicle has been returned to the Bureau of Motor Vehicles, Harrisburg, Pa., in accordance with the provisions of the Motor Vehicle Code or which by its appearance is unsightly and not in a repairable condition. **[Amended 9-6-88 by Ord. - § 80.2. Evidence that vehicle is of prohibited type.**

Where a certificate of junk has been issued by the Bureau of Motor Vehicles, such certificate shall be conclusive evidence that said vehicle is of the type which is prohibited by this chapter; and where no such certificate has been issued or applied for, the failure to have the vehicle licensed shall be prima facie evidence that the vehicle is of the type which is prohibited by this chapter.

**§ 80.3. Storage or accumulation of scrap material prohibited.<sup>1</sup>**

It is further declared unlawful to store, accumulate or keep openly on any property within the limits of Upper St. Clair Township any scrap material of any kind, any old scrapped or used appliances, fixtures, automobile parts, machinery and machinery parts or other similar material or any other form of discarded or unused or unusable materials (including building materials) which by their appearance are unsightly.

**§ 80.4. Notice to remove prohibited vehicle or material.**

80.4.1. The Township Manager or designated representative shall give ten (10) days' notice to the owner of any property upon which any such prohibited vehicle or material is found to remove the same, said notice to be delivered in person or by certified or registered mail. **[Amended 12-7-92 by Ord. 80.4.2. Any person who is the owner, occupier or user of the premises on which such prohibited vehicle or material is found shall be given the notice above required, and upon failure to remove the same after ten (10) days' notice shall be subject to the penalties hereinafter set forth.

**§ 80.5. Violations and penalties.<sup>2</sup>**

Any person who fails, neglects or refuses to remove any vehicle or material which is prohibited in this chapter after proper notice shall be subject to the provisions of Chapter 5, Enforcement of Ordinances; Penalties.
