NEW BUSINESS

Construction for the restrooms at The Boyce Mayview Pavilion will be ongoing through 2019 and mulch outside the C&RC is being replaced with grass.

The weekend of August 16 – 18, the Miracle League of South Hills will host the Regional All Star Game on August 16 – 18. Approximately 10 different leagues from different states will be attending. WDVE Morning Show will also be broadcasting live on August 16th.

The slide, piano and memory pad sensors at The Miracle Field is to be replaced before the Regional All Star Event.

The Miracle League of South Hills is in the design phase of enhancements including grandstand seating behind home plate, announcer's booth and a small concession stand.

Community & Recreation Center Annual Indoor Building Closure is Sunday, August 18th – Friday, August 23rd. Indoor Pool will be closed an additional week from August 24th – September 2nd.

The Facility Implementation Team (FIT Committee) is reviewing the surveys. They are also looking into hiring an Aquatics Consultant for enhancements.

Board members discussed the new shower curtains in the ladies locker room, the member/guest comments and the success of July 4th Fireworks Show.

The Community & Recreation Center (C&RC) has hired a new Guest Relations Coordinator – Tyler Walker.
